Introduction:

The Office of Federal Programs' MSIS User Manual assists Coordinators with providing the Mississippi Department of Education with complete, accurate and timely data.

MS Student Information System(MSIS) provides for the electronic collection and storage of comprehensive detailed data about teachers, administrators, students (Pre-K to 12) and school board members. MSIS also allows for the electronic transfer of student records from one school district to another, thus offering a unique student tracking system. The purpose of MSIS is to provide an efficient means in which to:

- Support the Mississippi Department of Education (MDE) performance-based accreditation model
- Support education funding programs
- Provide timely and accurate reporting of education data (schedules, attendance, grades, transportation, discipline, Vocational and Special Education) to meet state and federal requirements
- Allow for student tracking across the state to determine student mobility trends and to assist in the reduction of the drop-out rate within the state

This user manual provides a more detailed step by step approach where program coordinators can use MSIS to update, validate and report data more accurately and timely.

Accreditation Standards

2.1 ASSIGNMENT OF DISTRICT ACCREDITATION STATUS

In the fall of each year, the CSA determines the annual accreditation status of all public school districts based on verified accreditation data from the previous school year. An annual district accreditation status is assigned based on compliance with Process Standards. Information concerning district compliance with Process Standards is reported to the CSA on an annual basis. See Policy 2.2.

The district superintendent and school principals are responsible for ensuring that all data reported to the MDE are true and accurate as verified by supporting documentation on file in the school district. Reporting false information is a violation of the accreditation requirements set forth by the SBE and may result in the downgrading of the district's accreditation status.

After the CSA acts on accreditation records presented, during the fall, the district superintendent and the chairperson of the local school board are notified of the assigned status. The decision of the CSA is final unless appealed by the school board of the school district to the SBE in accordance with the appeal procedures in Policy 6.0 of this document. If a school board of the school district does not request a hearing before the CSA, they waive their right to any appeal of the CSA's decision.

2.9.4 PENALTY FOR THE WITHDRAWAL OF ACCREDITATION

Policy 2.9.3 is effective one (1) calendar year following the Withdrawal of Accreditation by the CSA and the SBE.

The withdrawal of a school district's accreditation by the CSA will result in the following:

- A school or schools within a district shall be limited to participation in no more than fifty percent (50%) of the regular season of any interscholastic activity, which shall include division/district/regional games,
- The interscholastic season schedule for a school or schools within a district shall not include the opening day of season or any type of post season participation, as determined by the Office of Accreditation, and
- Cheerleading, drill and dance squads, speech and debate, choral music, and band may participate in district or state contest, but shall not be eligible to receive ratings.

All schedule requests must be submitted in writing to the MDE's, Office of Accreditation, at least thirty (30) days prior to the beginning of the season. The Office of Accreditation shall pre-approve all schedules and participation in interscholastic activities. In addition to the suspension of all post season activities, the school district shall not be allowed to participate in jamborees, special games, parades, tournaments, holiday tournaments, or competitions of any nature.

Failure to comply with section 2.9.3 will result in the suspension of ALL interscholastic activities.

Failure of a district to have its accreditation reinstated by the CSA after a period of two (2) calendar years from the date of the withdrawal of accreditation shall result in the immediate suspension of ALL interscholastic activities until the district's accreditation status is reinstated.

Note: Interscholastic activities include, but are not limited to, football, basketball, baseball, track and field, cross country, tennis, golf, volleyball, softball (fast pitch and slow pitch), soccer, wrestling, swimming, power lifting, bowling, archery, cheerleading, drill, and dance squads, speech and debate, choral music, and band.

PROCESS STANDARDS ADMINISTRATION AND PERSONNEL

- 1. The local school board and the superintendent of schools shall exercise due diligence in performing the respective duties of each office in accordance with applicable law. The local school board's responsibilities shall pertain to matters of setting policy and shall not interfere in the day-to-day operations of the school district that include, but are not limited to, such duties as those relating to personnel and management decisions. Failure to comply shall result in the immediate downgrade of the district's accreditation status to Probation or Withdrawn as indicated in Accreditation Policy 2.5. Miss. Code Ann. §§ 25-41-1 et al.; § 25-61-1 through 17; § 37-3-4(5); §§ 37-6-7, 9, 11, and 15; §37-7-306(1-4); §§ 37-9-1 through 75; §§ 37-9-101 through 113; §37-7-301(p)(w); § 37-6-3(3-4); § 37-9-7, 13, 14; § 37-61-9; § 37-151-5(h); and Federal Civil Rights Act of 1964.
 - 1.1 The school board assigns all executive and administrative duties to the superintendent, who is properly licensed and chosen in the manner prescribed by law. Miss. Code Ann. § 37-6-3(3-4); § 37-9-7, 13, 14; § 37-61-9; and § 37-151-5(h).
 - School board policies that comply with state and federal statutes, rules, and regulations 1.2 serve as the basis of operation for the district, and current copies (print or electronic) of school board policies are published and available for public review. Miss, Code Ann. § 25-41-7; §§ 25-61-1 through 17; §§ 37-9-1 through 75; §§ 37-9-101 through 113; § 37-7-301(p)(w); and Federal Civil Rights Act of 1964.
 - 1.3 School board members complete required basic and continuing education programs in order to effectively perform their duties in the manner prescribed by law. Miss. Code Ann. §§ 25-41-1 et. al; §§ 25-61-1 through 17; § 37-3-4(5); § 37-6-7, 9, 11, and 15; and § 37-7-306(1-4).
- 2. All district professional positions requiring licensed staff are filled by staff that are properly licensed and endorsed as required by state law and federal requirements of the Elementary and Secondary Education Act (ESEA). Miss. Code Ann. § 37-9-77, Miss. Admin. Code 7-3: 80.1 and 80.2. State Board Policy Chapter 80, Rules 80.1 and 80.2, and ESEA, and Federal Code.
 - 2.1 The school district employs an appropriately licensed full-time principal at each school. The principal may not have any other job duties assigned in areas that require a specific work area code unless a waiver is granted by the Commission on School Accreditation. This standard does not apply to assistant principals. Miss. Code Ann. § 37-9-7, § 37-9-15, and § 37-151-5(g).
 - 2.2 With the exception of academic core subjects, the professional staff in each school is comprised of no more than 5% of Full Time Equivalent (FTE) units working outside the area or areas of endorsement. Assistant principals and administrative interns who are not properly endorsed may be included in the 5% FTE working outside their area of endorsement, provided they do not act in the place of the principal. An appropriate license is required for superintendents, principals, librarians, and guidance counselors.
 - 2.3 The school district employs in each school a licensed librarian or media specialist who devotes no more than one-fourth (1/4) of the workday to library/media administrative activities. Miss. Code Ann. § 37-17-6(3) (a-e). 2.3.1 If the student enrollment is 499 or less, a half-time licensed librarian or media specialist is required.

2.3.2 If the student enrollment is 500 or more, a full-time licensed librarian or media

specialist is required.

- 2.4 Student support services (appraisal, academic, and/or personal advisement, and educational and/or career planning and referral) are provided in each school by qualified student support personnel. Student support personnel may only provide those services and activities in the area(s) that each individual is specifically qualified to provide and will use only job titles that reflect same. Miss. Code Ann. § 37-9-79. 19
- 2.5 The school district employs a school business officer/administrator whose qualifications meet the criteria established by the Mississippi Department of Education and whose primary job responsibilities are conducting, supervising, and/or directing the financial affairs and operations of the school district. (Miss. Admin. Code 7-3: 71.1 and 71.2, State Board Policy Chapter 71, Rules 71.1 and 71.2.
- 3. The school district implements an annual, formal personnel appraisal system for licensed staff that includes assessment of employee on-the-job performance. Miss. Code Ann. § 37-3-46(b)
 - 3.1 Superintendent Evaluation using the assessment benchmarks established by the Mississippi School Boards Association (MSBA) and consistent with assessment components defined in Miss. Code Ann. § 37-7-301.
 - 3.2 Principal and Assistant Principal Effectiveness using the Professional Growth System (PGS) for Administrators.
 - 3.3 Teacher Effectiveness using the Professional Growth System (PGS) for Teachers.
 - 3.4 Counselor Effectiveness using the Professional Growth System (PGS) for Counselors.
 - 3.5 Annual employee performance data shall be submitted to the MDE following the guidelines in the MDE Educator and Administrator Professional Growth System Guidelines. Districts shall adhere to revision dates as determined by the MDE and implement only the current version.
 - 3.6 Administrators who rate school-level administrators, counselors, librarians, and teachers, and teacher-observers shall complete an MDE-approved Professional Growth System (PGS) training.
 - 3.7 Other, non-licensed, district staff evaluations as determined by local school board policy.
- 4. The local school board obtains an annual financial audit of the school district, as conducted under the guidelines of the Office of the State Auditor, no later than nine months after the end of the district's fiscal year. Miss. Code Ann. § 7-7-211(e) (Miss. Admin. Code 7- 3: 10.1, State Board Policy Chapter 10, Rule 10.1. 2 C.F.R. Part 200.
 - 4.1 The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, indicates a fixed asset system of accountability that provides verification of fixed assets and fixed assets records. Miss. Code Ann. § 37-17-6(18).
 - 4.2 The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, indicates no less than a zero fund balance (as defined by generally accepted accounting principles) for all funds of the school district. Miss. Code Ann. § 37-61-19.
 - 4.3 The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, verifies the process for distributing Educational Enhancement Fund procurement cards to all eligible teachers. Miss. Code Ann. § 37-61-33(3)(iii), Miss. Admin. Code 7-3: 32.1, State Board Policy Chapter 32, Rule 32.1.
 - 4.4 The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, indicates an unqualified

opinion (as defined by generally accepted auditing standards) on the financial statements of the school district. Miss. Code Ann. § 37-9-18(2) and § 37-61-29.

- 4.5 The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, verifies the local school board has received, reviewed and discussed, as reflected in official minutes of the regularly scheduled monthly meeting, the financial reports required by state law and/or the State Board of Education. Miss. Code Ann. § 37-9-18(1), § 37-37-7(2)(e), § 37-37-13, Miss. Admin. Code 7-3: 71.3, State Board Policy Chapter 71, Rules 71.3.
- 4.6 The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, verifies the accuracy and timely compilation and reporting of all financial data, including the year-end data provided through the Financial Exchange Transfer System (FETS), required for submission to the MS Department of Education by the fifteenth day of October, each year, in accordance with state law and/or the State Board of Education. Miss. Code Ann. § 37-37-7(2)(e), § 37-61-21(2), and § 37-37-13. 20
- 4.7 The most recent annual financial data of the school district, as submitted to the MS Department of Education, verifies a 7% fund balance of the district maintenance fund. Miss. Code Ann. § 37-61-8.
- 5. The most recent annual financial audit report of the school district, as conducted under the guidelines of the Office of the State Auditor, verifies the following:
 - 5.1 The local school board submits the annual budget to the levying authority and the prescribed budgetary information to the MS Department of Education by the fifteenth day of August, each year, in accordance with state law and/or the State Board of Education. Miss. Code Ann. § 37-61-9(1) through (3).
 - 5.2 The local school board budgets and expends funds under the Public School Health Insurance Plan as required by state law and State Board policy. Failure to remit premiums, interest penalties, and/or late charges in a timely manner may result in withholding a school district's adequate education program funds Miss. Code Ann. § 37-151-95, Miss. Admin. Code 7-3: 48.4, State Board Policy Chapter 48, Rule 48.4.





Once you get to the MSIS logon box shown below, you will need to enter your MSIS logon credentials and click connect.



Username – Your MSIS Primary Contact will be able to assist you with this. Password – Your MSIS Primary Contact will be able to assist you with this. Database – always enter *msis*

Once connected the window below is displayed. You have now logged into MSIS.




NOTE: Do not open multiple MSIS windows at one time -known as **Stacking** - this will lock or slow down the computer or possibly disable functions on other screens.

PASSWORDS

Always make sure that you close the browser when you leave your computer. Never let the computer remember the password for you. Never put the password on a sticky note on your computer. And NEVER share your password with anyone else.

You can change your password in MSIS at any time. Just go to *Security*, *Change User Password*. You can only change the Password for your Login Name.



On the Change Password screen, enter your old password, then your new password, re-enter the new password and click on OK. You should logout and log back in to be sure the new password works.

The Password must be at least 8 characters and not longer than 30 characters. The Password must contain at least one non-alpha character. The new password must be at least two characters different from the old password. Passwords will expire 60 days from the date of a change. Passwords not changed 30 days after date of expiration will be locked. Please contact your MSIS Primary Contact or MSIS Secondary Contact. They will be able to unlock a locked account. Any account will be locked after three failed login attempts and the user will have to contact the MSIS Primary Contact or MSIS Secondary Contact to unlock the account.

The Password Reset Policy is: User contacts their district's MSIS Primary or MSIS Secondary Contacts. MSIS Primary or MSIS Secondary Contact should contact the OTSS Help Desk at mdeapps@mdek12.org to reset password by emailing the name and last 4 digits of the user SSN that needs their password reset.

MSIS sessions will be logged out after 30 minutes of inactivity. A session where a "save" hasn't been executed or a screen change hasn't occurred is considered an inactive session. A session where a report is running is NOT considered an inactive session. If you are entering data but haven't saved within the last 30 minutes then your session will be considered inactive. You won't know the session is inactive until you try to save the data, so it is important to save regularly.

User Access Levels

There are specific levels granted to users either as District or School. Federal Programs Directors have access to District level information and any other access rights granted by the district MSIS Primary or Secondary Contact.

MSIS 2 Form and Oath of Confidentiality





Federal Programs Personnel

The federal programs director provides accurate information on salaried personnel to the MSIS Primary or designated MSIS personnel employee to input employees paid with title program funds into the SAP and MSIS.



United States Department of Education (USDoE) requires the data reported to answer the following questions:

- Which subject area teachers and paraprofessionals are paid by what federal program?
- Are teachers and paraprofessionals paid by federal funds meeting the Highly Qualified requirement?

The data is being captured in a data warehouse, where the information will be available to the public, and increase transparency in government programs and spending.

Best practice recommends: Keep a copy of the personnel report for federal funded staff for unscheduled audits and future monitoring.

NOTE: All district personnel must be entered in MSIS Personnel and approved **on or before September 30.**

Description:

Current School year – The manual is updated every school year and the previous year manual is no longer available via MSIS. The report displays active course codes for the school year.

District Office – is the work area in the district in which the course is assigned in MSIS

Course – code attached to a job title at every level of the district

All Grades – identified grade level assigned to a course code. This may also indicate a particular area at the school level.

Course Title – job title with or without brief qualifications listed

Endorsements – a code of certification required to obtain particular employment.

Note: Various licensed positions require two or more endorsements to occupy the job title.

The & (and) symbol that separates the endorsement codes defines that the employee must be certified with both endorsements listed with the course code.

<u>e.g. 486 & 488</u>

Carnegie - The number of units assigned to a subject area course code. The units assigned are based on the subject area course being taught at a minimum of 9 weeks up to a full academic school year.

Special - the program code(s) from which the salary is paid for each course code.

CIP (Classification of Instructional Programs) – code developed by USDoE to track Career and Technical Education programs on a national level. This code is only used with CTE course codes.

Once federal personnel has been selected and entered in MSIS, request a copy of the **Accreditation Edit Report** from the MSIS Personnel designee assigned in the district. This report will indicate any errors that exist with federal personnel per course code.







LEA's also must ensure that the hiring of these substitutes' supplements, and does not supplant, the use of local and State funds they would otherwise be spending for such substitutes.

Title III Funds (3) are used: (1) To pay the salaries of before and after school tutors and academic assistance. (2) To employ bilingual/ESL coaches whose role is to acquire scientific-based research practices, provide professional development, mentor and coach teachers who are working directly with ELs. The funds can be used to provide stipends to teachers to assist them in completing and obtaining bilingual/ESL endorsements. Support for personnel, including paraprofessionals who have been specifically trained, or are being trained, to provide services to immigrant children and youth. Title III funds may NOT be used to pick up a cost that was previously funded by general funds **and may NOT supplant** any other federal, state or local expenses.

Other Special Funds (9) are used to pay salaries: Please refer to the specific federal programs (i.e., special education, 21st Century, etc.) guidelines to ensure that funding of teachers and paraprofessionals is an allowable expense.



- b. Children and youth who have a primary nighttime *residence* that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human

beings;

- c. Children and youth who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings; and
- d. Migratory children (as defined in section 1309 of the Elementary and Secondary Education Act (ESSA) of 1965, as amended) who qualify as homeless because they are living in circumstances described in this definition.

The permitted values to be selected in MSIS for primary nighttime resident are:

Shelters - transitional housing

Doubled Up - sharing the housing of other persons due to economic hardship, loss of housing or other reasons (such as domestic violence)

Unsheltered - includes cars, parks, campgrounds, temporary trailers including FEMA trailers, or abandoned buildings

HM - Hotels/motels

Unaccompanied homeless youth - includes a youth not in the physical custody of a parent or guardian.

Definition of Homeless

The following definition, as provided, in the McKinney-Vento Homeless Assistance Act, must be used by the Local Education Agencies (LEAs) when determining the homeless status of a student. The term "homeless" includes children and youth who experience any of the following:

Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason. If economic hardship, such as an accident or illness, loss of employment, loss of public benefits, or condition of poverty, forces a family or youth to share the housing of others temporarily, the children and youth are eligible for McKinney-Vento services. Along-term, cooperative living arrangement among families or friends that is fixed, regular and adequate should not be considered a homeless situation, even if the parties are living together to save money.

Living in a motel, hotel, trailer park, or camping ground due to the lack of alternative adequate accommodations. Motels, hotels, and camping grounds will almost always be homeless situations, as they are rarely fixed, regular, and adequate residences. Asking questions about the condition and size of the trailer, the number of people living there, the intended length of stay, and whether the family or youth has an adequate alternative will help determine if the student is eligible for McKinney-Vento services.

Living in an emergency or transitional shelter. Emergency or transitional shelters of all kinds, including youth shelters, domestic violence shelters, family shelters, transitional living programs, and supportive housing programs are homeless situations.

Abandoned in hospitals. A child or youth abandoned in the hospital is eligible for McKinney-Vento services.

Living in a public or private place not designed for or ordinarily used as a regular sleeping

accommodation for human beings. An example of a place that meets these criteria is a public restroom.

Living in a car, park, public space, abandoned building, substandard housing, bus or train station, or similar setting. In evaluation whether housing is "substandard," consider that substandard means "deviating from or falling short of a standard or norm" or "of a quality lower than that prescribed by law." Determining if housing is substandard requires comparing the housing with community norms and the law.

Classified as migratory children who qualify as homeless for the purpose of this subtitle because the children are living in circumstances described above. While migrant students are not categorically eligible for McKinney-Vento services, migrant students living in a primary nighttime residence that is not fixed, regular, and adequate are eligible.

MSIS requires the indicator to be marked "Y" after the student has been determined to be a migrant student by MMESC.

Migrant student data is captured, stored and reported in the MIS2000 database on behalf of the MDE by MMESC, at Mississippi State University. This system collects and stores Migratory data for the state of Mississippi and over 25 other states. Data collected in MIS2000 is shared with MDE and the U.S. Department of Education, Office of Migrant Education. MIS2000 is owned and operated by Management Services for Education Data (MS/EdD), in Little Rock, AR.

Note: School Districts <u>do not</u> make the determination of whether a student is marked as a migrant student in MSIS. This determination can only be made by MMESC. A list of qualifying migrant students will be sent to districts from MMESC. It is very important to accurately report the information in MSIS as indicated in this migrant student list. Accurate data entry enables MDE's accurate submission of a required biannual report on migratory students educated in Mississippi to the U.S. Department of Education, Office of Migrant Education.

Title I, Part D – Subpart I (State Agencies) and Subpart II (District)

Title I, Part D consists of 2 discretionary subparts. Subpart 1 is allocated to state agencies (Mississippi Department of Corrections and Mississippi Department of Human Services/Division of Youth Services). Subpart 2 is allocated to school districts with institutions, in their local attendance areas, for children meet the federal definition of delinquent (juvenile detention centers).

A delinquent child as defined in section 1432; 4(B) of ESEA is a child or youth ages 15-21 who have been placed in a facility because they have been adjudicated to be delinquent or in need of supervision by court orders.

The student indicator is selected in the student package with a "Y" at the homeschool.


Note: Once a student has entered a Juvenile Detention Center (JDC) the indicator must be selected to "**Y**" and an incident identifying the student action is created and sent to MSIS within 72 hours. Then it is followed by the disposition of JDC with the duration days of stay at the facility. This information is sent from the homeschool as a Daily Student Data (DSD) file. The indicator must remain checked until the student returns to the homeschool. If a student has served only a weekend in the JDC, please check the indicator immediately and leave selected until the monthly student data file has been accepted at MDE, then change the student indicator to "**N**" in the SAP.

A student must **remain enrolled at the homeschool and marked present everyday** while in the JDC until they return to the homeschool. The student **must be released in MSIS** to the JDC or state approved coordinating facility that request a release of the MSIS ID.

Students **that have been sentenced to an adult correction facility or prison** must be removed from the homeschool enrollment with the appropriate dropout code with supporting court documentation.



- Districts must submit/approve Month 04 Monthly Student Data Transaction (MSD files) by January 13th
- Incoming December Kindergarten student deadline is January 13th
- School Board member data is due to be updated no later than January 31st
- Rights to the General/Schedule Entry screen are restored after Christmas Break.

FEBRUARY

- Districts must submit/approve Month 05 Monthly Student Data Transaction (MSD files) by February 10th
- Incoming January Kindergarten student deadline is February 10th

MARCH

- Districts must submit/approve Month 06 Monthly Student Data Transaction (MSD files) by March 10th - Incoming February Kindergarten student deadline is March 10th

APRIL

- Districts must submit/approve Month 07 Monthly Student Data Transaction (MSD files) by April 10th
- Incoming March Kindergarten student deadline is April 10th

MAY

- Districts must submit/approve Month 08 Monthly Student Data Transaction (MSD files) by May 10th
- District must enter next school year's calendar in MSIS District Events by May 30th

JUNE

- Districts must submit/approve Month 09 Monthly Student Data Transaction (MSD files) (10 days after student's last day of school)
- Districts must use the Year End Student Transfer screen to move students from one school to another before records are built for the new school year. Last Day is June 30.
- Districts may submit Initial Student Load Transaction files (ISL files) from June 1 to September 30. This is only for students who are under the age of 7 and need MSIS Ids
- Districts must submit Monthly Student Historical File (MSH file) as soon as Month 9 is completed
- Graduation Option deadline for seniors is June 30th .
- Districts must complete Summer Program Report Entry screen for all schools offering summer programs
- Districts must complete Teacher Absence Information. Last Day is June 30.
- MSIS is closed for maintenance on June 30.

SUMMER ACTIVITIES

- Districts may submit Initial Student Load Transaction Files (ISL files) to MSIS from June 1 st until September 30th. This is only for students who are under the age of 7 by September 1st and do not already have MSIS IDs.
- Districts may submit Summer School Files (SSD files) to MSIS from June 1 st until the 2nd Monday in September.
- Districts (Public, Special, & Non-Public) should roll Personnel data from last school year and begin working on Personnel for the new school year. Rolling Personnel also rolls Sped Student Data to the new school year.
- Districts should update District and School Demographics for the new school year and make changes during the school year as needed. School Board Member data should be updated as needed also.
- Make adjustments to Graduates/Completers and Promotions/Non-Promotions on the Update Student Grades screen (Update Promotion tab).
- The post-graduate plans for the students who are prior-year graduates/completers should be entered in MSIS by August 31st using the Post-Graduate Plans screen.

TYPICAL MONTHLY PROCESS

- Each school should have MSIS IDs for and ownership of all of their students by the end of the reporting month.
- Send Daily Student Data (DSD) files as needed to change a student's Special Education status (Y or N) and/or report incidents.

- Create MSD files and run them against the pre-processor to check that student and teacher schedules are matching, school has ownership of the students, etc. prior to sending MSD file to MSIS.
- Personnel should be approved each day that changes are made so the MAEP and Accreditation procedures will run at night for the approved districts.
- Begin submitting Reporting Month (MDT and MSD) files at noon on last school day of reporting month. (If the last day of the month falls on a weekend then file submission begins at noon on the last Friday of the month).
- Once a school has a Success, run Pre-Approved Monthly Attendance Report and all Holding Area reports.
- Check the data on the reports to insure accuracy of submitted data. Keep hard copies of Holding Area reports or save PDF files of Holding Area reports for auditing purposes. Approve school in MSIS if data is correct in Holding Area. Once all schools are approved, approve the district. The deadline for a reporting month is the 10th of the following month.

IN JULY:

- •MSIS will be unavailable on July 1 st .
 - Build ownership files for new school year.
 - Roll data that needs to be rolled (personnel, etc).
 - Run procedure to increase Years of Experience by 1 on employees who had 100% District Time previous school year.

Glossary

Disposition: the disciplinary action decided upon by the school or district administration to be completed by a student before returning to the classroom.

Daily Student Data Transaction File (DSD) Submit on a daily basis if you suspend or expel a student for a violent act OR if the status of a Special Education student changes. This file must be submitted within the month the incident occurred. If you cannot submit during the month of the incident (the incident happened on the last day of the month, but the district didn't take action until the 3_{rd} of the next month), do not submit a DSD file. The student information will be updated with the MSD file.

Some incidents should be sent within 72 hours of the incident. These are Fighting, Homicide, Kidnapping, Mayhem, Poisoning, Rape, Robbery, Staff Assault, Stalking, Sexual Battery, and Weapon Possession.

You can get a complete list of incidents reportable in MSIS from the MSIS Information page at <u>http://www.mde.k12.ms.us/management-information-systems/ms-student-information-system-(msis)/for-students</u>. This document lists the incidents and dispositions to be reported in MSIS. Definitions of each incident code are included.

Incident: the action/crime conducted by a student, on and off campus, during the school year that requires a disciplinary action to be decided upon by school or district administration.

Monthly Student Data Transaction File (**MSD**) Submit one successful MSD per school per reporting period. This file contains students' schedules, demographics, emergency information, incidents, attendance, enrollments, withdrawals, class schedules, program indicators and grades with credits received. This information has been entered at the home school into the school administrative package.

Monthly Days Taught Data Transaction File (MDT) Submit one MDT per school per reporting period. This file should be submitted first for your monthly reports. Once you have a Success, you do not have to submit this file again until the next reporting period. This tells MSIS how many days were taught at this school for each grade for this reporting period.

Reporting Period – the student school attendance month **NOT** a calendar month. Please refer to the district timeline listed above.

Student Administrative Package -SAP –is a district-level software package that allow school districts to manage student, personnel and other pertinent school data on a daily basis. The software must have the capabilities of exporting data into MSIS. School districts select and purchase the school software company. *MDE employees are strictly prohibited from the decision and purchasing of the software at the public and non-public district level. MDE employees are forbidden access to the software packages purchased by the districts.*

Start Month/End Month – Standard Calendar Months

Targeted Assistance School - primarily addressed in <u>section 1115 of Title I. Part A.</u> is one that receives Part A funds yet is ineligible or has chosen not to operate a Title I schoolwide program. The term "targeted assistance" signifies that the services are provided to a select group of children--those identified as failing, or most at risk of failing, to meet the State's challenging content and student performance standards--rather than for overall school improvement, as in schoolwide programs. Like schoolwide program schools, the goal of a targeted assistance school is to improve teaching and learning to enable Part A participants to meet the challenging State performance standards that all children are expected to master. To accomplish this goal, a targeted assistance program must be based on effective means for improving achievement of participating children; use effective instructional strategies that give primary consideration to extended-time strategies, provide accelerated, high-quality curricula, and minimize removing children from the regular classroom during regular school hours; coordinate with and support the regular education program; provide instruction by highly-qualified and trained professional staff; and implement strategies to increase parental involvement

Report Glossary

Holding Area Report – A report that is created in MSIS before the approval of the district MSD file and it allows verification of the data. go to REPORTS>STUDENT ROSTER>HOLDING AREA and run the report and verify that all students have been sent. Other Holding Area reports should also be run at this time. These reports are: Holding Area Student Entries, Holding Area Student Withdrawals, Holding Area Incidents/Dispositions, Holding Area Student Indicators, Holding Area Absences, Holding Area Carnegie Unit with No Credit (important for Month 09), and Holding Area Vocational Student Indicators. A hard copy or PDF file of each month's Holding Area reports should be saved for auditing purposes. These reports are accessed by going to REPORTS>STUDENT DATA>HOLDING AREA and then selecting the desired report. If the reports look okay, then go to the APPROVE IMPORTED STUDENT DATA screen and click in the Approved field for that school. The date will default to the current date. You WILL NOT be able to approve a school if the PRE-APPROVED MONTHLY ATTENDANCE REPORT has not been run. Click on the green diskette in the upper left corner to save the approval. Repeat this until all schools have been approved.

Holding Area Student Indicators - the report that is a list of students with a particular indicator selected in the SAP and/or last submitted in the MSD file that is in the Holding Area. The user can choose an indicator and run a listing of students with that indicator marked in the last submitted MSD file that is in the Holding Area. For example, the user could run a listing of all students marked as Gifted or a listing of Voc Ed students, or a listing of Special Ed students.

Holding Area Vocational Student Indicators - This report list student name, MSIS ID, Grade Level, Vocational Indicator, LEP Indicator, Capstone Indicator, Disabled Indicator, Disadvantaged Indicator, Nontraditional Indicator, Single Parent Indicator, and Displaced Homemaker Indicator for students in the selected school who have a Vocational Indicator of Y in the Holding Area. This allows you to verify the data before approving the school for the reporting month.

Holding Area Student Entries - This report lists the student's name, MSIS ID, and grade level alphabetically by school based on data in the Holding Area. This allows you to see the students that were sent in with an entry in the MSD file. The District Student Administrators and School Student Administrators have rights to run this report.

Holding Area Student Withdrawals – This report lists the student's name, MSIS ID, and grade level alphabetically by school based on data in the Holding Area. This allows you to see the students that were sent in with a withdrawal in the MSD file. The District Student Administrators and School Student Administrators have rights to run this report.

Holding Area Incidents/Dispositions - This report lists the incident description and disposition code with totals of each that are in the Holding Area. This allows you to see the incidents/dispositions that were sent in the MSD file. The District Student Administrators and School Student Administrators have rights to run this report.
