The Hattiesburg Public School District is a <u>model teaching and learning</u> community that graduates productive and caring citizens who are prepared to succeed.




HPSD Goals

- 4. Fiscal Accountability: Maintain sound fiscal practices.




HPSD MV Population

Use of Funds for MV Students

- Title I Funds
 - Transportation
 - All instructional opportunities that every student receives
- McKinney-Vento Grant
 - Homeless Liaison
 - Supplies
 - Transportation



MV Eligibility

- Who qualifies for McKinney Vento?
- The McKinney-Vento Act defines "homeless children and youths" as "individuals who lack a fixed, regular, and adequate nighttime residence." Lacking any one of these three conditions would make a child **eligible**. In other words, if the residence is not fixed, regular, and adequate, it is considered a homeless situation.
- This includes doubled up, hotels-motels, shelters, unsheltered **Unaccompanied youth** as "a homeless child or **youth** not in the physical custody of a parent or guardian" [42 USC § 11434a(6)].



MV Eligibility Determination

- School districts must determine whether a student's living arrangements meets the McKinney-Vento definition of homeless.
- Establish a district protocol incorporating clear guidance
 - ** Steps to take when working with MV students and families
 - ** Steps to take when information received about a student's living arrangement needs to be confirmed
 - ** Personnel who will be involved in the determination process (e.g. school counselor, district MV Liaison, etc.)
- Guidelines should be established which involve personnel when determining eligibility, included recommended and prohibited practices



MV Eligibility

- Use of an interview questionnaire that incorporates informative, yet non-invasive, questions about a student's living arrangement as part of enrollment paperwork.
- Use the information gathered on this questionnaire to assist with making determination of MV
- This interview should be conducted by the designated McKinney Vento Liaison (school, district, etc.)



MV Determination

- As required by the McKinney –Vento Act, students who qualify will need to be enrolled immediately, even if they are unable to provide the necessary documents normally required for enrollment.
- Train district and school staff on McKinney-Vento Act's definition of homeless and steps to take if working with a student who meets eligibility.



MV Services

- MV students must have access to the educational and other services they need to ensure that they have an opportunity to meet the same challenging state student academic achievement standards to which all students are held.
- School Selection (School of Origin)
- Immediate enrollment
- Transportation
- Local Homeless Education Liaison (must be designated)



MV Services

- Free Breakfast and Lunch
- Clothing and supplies needed to meet school requirements
- Tutoring Services (if necessary)
- After School Services
- Expedited Evaluations
- Early Childhood Programs
- Emergency assistance related to school attendance
- Before/after-school mentoring, summer programs



MV Services

- Counseling
- Assistance with participation in school programs
- Addressing needs related to domestic violence
- Obtaining or transferring records necessary for enrollment
- Parent education related to rights and resources for children
- Referrals for medical, dental, and other health services
- Referral to other programs and services
- Staff professional development and awareness

Homeless Liaison Services

- Initial contact with students identified as MV
- Ensure their basic school needs are met, i.e. uniforms, back packs, school supplies, transportation/bus schedule
- Parent contact if necessary, i.e. Where is the family living?
- Are they in a shelter? Living in a car? Living in a motel/hotel? Do they have personal transportation? Are they working? Food?
- Working closely with counselors, principals, and district office

 - Pine Belt Coalition on Homelessness
 - Edwards Street
 - PRVO
 - Boys and Girls Club
